The **European Brabant Studbook** is designated for imported, purebred horses from European Brabant Registry of America recognized registries (see *official Handbook*) and >93.75% offspring of purebred, registered European Brabant sire and dam pairings.

The **European Brabant Stock Studbook** is for horses who have a minimum of 47% verifiable European Brabant heritage, and lineage from other draft breeds.

The **Appendix Brabant Record** is designed to track and record draft crosses and light horse crosses with >25% European Brabant heritage as well as higher-percentage horses who do not meet the breed color standards.

## APPLICATION INSTRUCTIONS:

If completing by hand, please write in block lettering.

When registering foals, provide two name options, not exceed 40 characters including prefix & spaces

If you are the breeder, and are on file with the EBRA, simply put your Member Number below and skip the Breeder's information sections and State/Country Foaled field (*unless foaled somewhere other than your farm*).

If your horses are from the same breeder, simply complete the first horse's Breeder information fields and check the SAME box next to correlating horses and skip those horses' Breeder's fields.

## REQUIRED DOCUMENTS CHECK LIST

### Photographs

- All registration applicants are required to submit one full side view image of the horse with its head tilted slightly to camera and all four legs visible. Ensure the background is clutter free, the horse clean of saddle or harness, all white markings are visible and adequate space around the animal is provided - do no crop into the horse.

### Breed-Up Applicant Requirements

- Horse must be >2 years old
- All evaluation applications must include five photos: full left side view, full right side view, rear view, front view and head-shot and a video showing the horse's movements at the walk and trot are required at time of registration (*see handbook for details*)
- A **Breed Standard Evaluation Form** must be filled out and submitted at time of registration and required fee paid
- Horses registered as European Brabant Stock must return the Certificate of Registration upon acceptance into the European Brabant Studbook

### Imported Horse Applicant Requirements (*if applicable*)

- Include copies of passport – including pedigree charts
- If available, provide bill of sale between purchaser and European seller
- If available, include importation documents such as shipping contracts and quarantine documents

### Other Certificates of Registration

- Include copies of all Certificate of Registrations with other organizations
- Show front and back (*if certificate is double-sided*)

### DNA Profile, JEB and PSSM1

- If the horse has been DNA, JEB and PSSM1 tested, please provide a copies
- If performed by someone other than UC Davis Lab, a filing fee is applicable

### Breeding Certificate

- Required for foals being registered by those who did not own the sire at the time of breeding, which includes leased stallions, shipped cooled semen and/or imported frozen semen

### Stallion Leg Health Report

- All stallions >2 years at the time of registration are required to submit a **EBRA Leg Health Report** performed by a licensed DVM and submitted with current radiographs (*see handbook for details*) and required fee paid
